**NOTICE:** Skiers and ski lift passengers are governed by the New York State Safety in Skiing Code (Article 18, of the NYS General Obligations Law). Before accepting this pass or allowing this pass to be affixed to your person, your attention is directed to a posted "WARNING TO SKIERS" which is printed below and where lift passes are purchased. New York Law requires you to seek out, read, review and understand the "WARNING TO SKIERS" before you decide to participate in the sport of skiing.

**WARNING TO SKIERS:** Downhill skiing, like many other sports contains inherent risks including, but not limited to the risk of personal injury including, catastrophic injury, or death, or property damage, which may be caused by variations in terrain or weather conditions; or, surface or subsurface snow, ice, bare spots or areas of thin cover, moguls, ruts, bumps; or other persons using the facilities; or rocks, forest growth, debris, branches, trees, roots, stumps; or, other natural objects or man made objects that are incidental to the provision or maintenance of a ski facility in New York State. New York law imposes a duty on you to become apprised of, and understand, the risks inherent in the sport of skiing, which are set forth above, so that you make an informed decision whether to participate in skiing notwithstanding the risks. New York law also imposes additional duties upon you, to which you must adhere, for the purpose of avoiding injury caused by any of the risks inherent in skiing. If you are not willing to assume all of these risks and abide by these duties, you must not participate in skiing at this area.

**ASSUMPTION OF RISK AGREEMENT:** I have read and understand the NOTICE above. I have read, reviewed and understand the WARNING TO SKIERS printed above. In signing this application and receiving the Season Pass, I signify that I am aware of and understand the risks inherent in the sport of skiing and that I am accountable for my action as set forth on the WARNING TO SKIERS signs. I agree that this acknowledgment shall be for the entire term of the season pass.

## SEASON PASS INFORMATION AND CONDITIONS OF PURCHASE

- All purchases final. NO REFUNDS FOR ANY REASON INCLUDING, BUT NOT LIMITED TO: SICKNESS, INJURY, HEALTH PROBLEMS, RELOCATION, WEATHER CONDITIONS, NATURAL OR MANMADE DISASTERS. A MINIMUM NUMBER OF OPERATING DAYS IS NOT GUARANTEED. SEASON PASSES ARE NON-TRANSFERABLE AND NOT AVAILABLE FOR RESALE.
- Age as of date of purchase determines eligibility for all products except the 70+ pass; those turning 70 during the 2019 calendar year may purchase in advance of their birthday. Proof of age required.
- Pass photos from the 2018-2019 season may be used for the 2019-2020 season, at Gore Mountain's discretion. We will take a new photo upon request. We accept "passport" type digital images via e-mail to [sp@goremountain.com](mailto:sp@goremountain.com).
- A plastic identification pass will be issued with each season pass purchase. This identification pass, property of Gore Mountain, serves as a permanent lift ticket for the season. This pass must be clearly presented to ticket checker/ scanners above the waist on every lift boarding occasion.
- If the identification pass is lost or stolen you must notify Gore Mountain at once. A fee of \$25 will be charged to process a new pass. A one-day ticket replacement will be issued only one time during the season for a lost or forgotten pass. After that, a fee of \$5 per day ticket will be charged for forgotten passes.
- Season passes are non-transferable and are for the applicant's exclusive use. Use by another person constitutes fraud and will result in revocation of the pass and possible prosecution.
- Ski area regulations are enforced by the reckless skier policy and New York State Code Rule 54, Article 18, "Safety In Skiing Code." Any misuse, fraudulent use, misconduct or nuisance caused by the passholder or failure to follow New York State law may result in recall of the pass without refund or other considerations. Gore Mountain management reserves the right to recall season passes depending upon the severity of the infractions.
- Non-holiday season passes are not valid during the following holiday periods: Christmas Week Wednesday 12/25/19 through Wednesday 1/1/20; Martin Luther King Weekend Saturday 1/18/20 through Monday 1/20/20; President's Week Saturday 2/15/20 through Sunday 2/23/20.
- All pass applicants ages 18 and over must sign this application before it can be processed and the pass distributed. A parent or legal guardian of persons under age 18 must complete and sign the application and the Season Pass Assumption of Risk Agreement.
- All dates, rates and provisions are subject to change without notice. Gore Mountain holiday periods may be different than those at other ORDA venues and may be different than holiday periods noted for purchasing lift tickets.
- For the entire term of the pass, I relinquish my right to a refund of the purchase price of the pass purchased that is allowable under the Safety in Skiing Code for those persons unwilling to ski because of the risks of the sport or the duties imposed upon skiers by law.
- By purchasing this season pass, the holder understands and agrees that the New York State Olympic Regional Development Authority, Gore Mountain, or other business partners may utilize any photograph, video or recording of them for any purpose without further release.
- I have sought out, read, and agree as a passholder to adhere to the entirety of Gore Mountain's Skier's Responsibility Code, which includes, but is not limited to, an agreement to show respect for others both on and off the slopes and to keep off closed trails and closed areas.
- Free financing is available when you purchase on or before 8/16/19. We will charge a minimum of 25% of your total (more if you prefer) on the date of purchase. The remainder will be charged in three more equal installments, to occur on the 15th of each month following the initial payment. Financing requires a credit card on file with an expiration date after the last installment date. Should this card decline or be canceled during the financing period, the purchaser is responsible for updating Gore Mountain with valid payment, or will forfeit all previous investments in the season pass.
- For full-time college students ages 20+, we use a national database to verify enrollment status. If your school is not represented in the database, we will contact you so we may verify your status as a full-time student.
